## Middle East Fire Safety Systems & Equipment Market Revenues

The fire safety systems & equipment market in the Middle East region grew moderately in the past years. However, a few countries in the region such as UAE and Qatar, witnessed substantial growth as the construction sector in these countries was undergoing a phase of rapid expansion during the period 2017-2019 on the back of major events that were to be held in these countries. However, *The fire safety systems & equipment market revenues are anticipated to decline in the year 2020 as a result of complete or partial lockdowns and suspension of economic activities during the first half of the year in order to curtail the spread of COVID-19 pandemic.* 


#### Middle East Fire Safety Systems & Equipment Market Revenues, 2015-2026F (\$ Million)

Middle East Fire Safety Systems & Equipment Market Revenue Share, By Countries (2019)



Self contained systems are the most common type of emergency and exit lighting systems in the Qatar on account of its easy installation and lower maintenance. Also, self contained systems are the most cost-effective solutions for small to medium sized projects.

Detectors acquired a major share in the fire detection and alarm systems market in Middle East region in 2019 as the detectors are mandatory to be installed in business buildings, educational buildings, mercantile, healthcare, industrial occupancy, and hotels, as per the fire protection department guidelines.

## Middle East Security, Safety and Fire Protection Market Drivers



#### **Diversification of Economy**

- Ever since the oil prices declined in the year 2014 and adversely affected the Middle Eastern economy, countries such as Oman, Saudi Arabia, and UAE are looking beyond oil to diversify the economy. Under the same, the Saudi stock market (Tadawul) was opened to foreign investors. Additionally, Saudi Arabian General Investment Authority (SAGIA) announced that it would allow 100% ownership of retail and wholesale business to encourage further foreign investments in the Kingdom.
- Further, on account of rapid urbanization, rising disposable income of the middle-class population, strong economic growth, and regional integration, the construction industry in the African continent is also going through a phase of improvement. The construction of new commercial, residential, mixed-used hotels, healthcare, industrial, and healthcare buildings in the coming years would translate in significant growth for security, safety and fire protection market in the Middle East region.

#### **Stringent Government Regulations**

- The government of countries, such as Saudi Arabia, Qatar, and UAE are undertaking all necessary measures to improve the fire safety regulations in their respective countries such as in UAE, in high rise buildings, the most restrictive and high rise building provision for fire safety systems shall apply to the whole and every portion of the building as per standard NFPA 5000, NFPA 501, NFPA 502, NFPA 409, NFPA 294, NFPA 130, NFPA 88A, NFPA 30, and IBC.
- In another instance, the Civil Defense Ministry of Interior, State of Qatar has laid down the basic requirements related to general fire safety in the country. The guidelines and annexures laid down are to be followed as stated by the Government of Qatar. It is already mandatory in the region to install fire safety systems and equipment in all the buildings for the safety of the people. The Government of Qatar has also proposed that industrial, commercial, and general stores would not be given grants unless it has been scrutinized that they have a good fire detection systems.
