Intersec Awards is the region's premier award show that celebrates groundbreaking technologies, impactful projects, and extraordinary individuals within the fire, safety and security industries. Scheduled to be held on 13th January 2026, the Intersec Awards 2026 marks the fifth edition. The awards provide an invaluable platform to acknowledge and promote best practices, technological advancements, and industry leadership.

It will help you choose the right category for your nomination and guide you through the nomination process. It outlines the steps to ensure a seamless nomination form completion, details the evaluation process, and presents the submission, evaluation, and timeline requirements.

Entries will be submitted via our online portal, where you can complete your entry online and update it right up until the entry deadline.

ENTRY GUIDELINES

Answers should be in bullet point format only

Entries must be clear, concise, and avoid sales-oriented, brochure-like content

Video submission for your respective product or project is mandatory

Self-nominations are not permitted for Individual award categories; Messe Frankfurt Middle East/Intersec reserves the right to reject such entries

The entrant should submit valid email ids and operational mobile numbers only

Any entry submitted in monosyllables or an incomplete entry will be rejected.

Highlight what has been done differently. The judges are keen to hear about innovation and new approaches

Submit entries only if authorized; Messe Frankfurt Middle East/Intersec may reject unauthorized submissions by representatives from the company

Companies may submit unlimited entries across categories, but each product/service can appear in only one category. If duplicated, judges will score only the most relevant submission

Eligibility

This category is open to testing laboratories, evaluation bodies, certification entities, associations, and code and standards developers.

The entries must provide evidence of the significant impact their services have had on improving safety and security outcomes, such as enhancing system reliability, ensuring regulatory compliance, or identifying and mitigating potential risks.

JUDGING PANEL

The Intersec Awards judging panel features senior industry professionals with extensive knowledge and expertise and have been appointed to carefully evaluate each entry within the Fire & Safety/ Security/ Industry categories.

Prior to judging, panel members must disclose any affiliations or conflicts of interest related to competing entries. Judges with declared affiliations will abstain from scoring entries in the respective category, ensuring a fair and unbiased evaluation process.

A team of 2-3 judges will work together as a pair to lead evaluations for two categories and will have the opportunity to review the entries in those specific categories



The top-scoring entries from each category advance to Round 2 via the online voting process

VIDEO GUIDELINES

- Maximum length 5 to 6 minutes long
- Keep it concise, share insights into why your product/ project stands out
- Apart from product showcases, videos could/should also be interviews, spoken third party testimonials, 'Behind the scenes' or 'day in the life' footage, event footage from speaking at conferences or accepting awards, etc. especially in the Industry categories.
- Accepted format MP4, MOV, AVI
- Recommended resolution 1920x1080 (Full HD) or higher
- Ensure good lighting
- All videos must be in English. Ensure clear audio narration
- Content Structure reference Introduction, highlight the product/ project/ team's achievement, challenges addressed, USPs etc..
- Use real footage of product/ project wherever possible
- Avoid promotional, sales or marketing heavy language

TERMS & CONDITIONS

- Companies can submit entries in multiple categories, please select all the award categories that you wish to nominate in one go for an easier nomination process.
- Nominating the same product across categories is not allowed– Refer to the product groups, and submit your entry in the most relevant application.
- All the products/ projects/ solutions should have been implemented or launched within August 2024 – July 2025
- All nominations must be submitted online.
- All completed nominations must be in English and received by 15 September 2025 to be considered for judges' evaluation.
- Nominations must be clearly written and remain within the submission guidelines
- Messe Frankfurt Middle East / Intersec shall have the right to verify the information provided in each submission, if required

TERMS & CONDITIONS

- Messe Frankfurt Middle East / Intersec and the judges reserve the right to alter the categories or re-allocate entries between categories, as they see fit.
- In addition, if no entry is received in any category, or if the Judging Panel considers that no entry provides sufficient evidence of outstanding performance, no award will be given in that category.
- Nominations will be accepted in good faith and, notwithstanding any attempts to verify claims made in nominations, will be treated as true and accurate.
- Submission of entries indicates acceptance of the conditions of entry. In the event of any disputes or issues the decision made by the judges shall be deemed final. The organizers will not be obliged to justify their decisions or enter into any correspondence.
- All nominations and supporting information submitted will be treated as confidential and are only available for the Judging Panel whose members are bound by a Confidentiality Agreement.
