How to Enter:

- All nominations should be submitted online at: https://intersecawards2025.evalato.com/
- For the Product categories, eligible entries are for those products that have been launched, marketed and distributed in the region since 2023 2024
- Nominations must be in English and received by 20th August 2024

Entry Fees:

The Intersec Awards are FREE to enter.

Entry Guidelines:

- Answers should be in bullet point format only
- Word limit 500 to 1000 words submitted in bullet point format
- Entries should be submitted in a clear and concise manner and not resemble content from a product brochure. The answers should not be a sales pitch
- No self-nomination is allowed within the Individual award categories. Messe Frankfurt Middle East/ Intersec holds the right to reject any
 entry that is self-nominated
- Companies can submit entries in multiple categories without any limit. However, each product or service can only be featured in one
 entry. If the same product is replicated across categories, the judging panel will reject the other submissions and only score
 the most relevant Refer to the product groups
- Any entry submitted in monosyllables or an incomplete entry will be rejected.
- The entrant should submit valid email ids and operational mobile numbers only.
- Only submit an entry if you are authorized to do so. If brought to our attention, Messe Frankfurt Middle East/Intersec holds the right to cancel any entries by unauthorized representatives from the company.
- Keep it crisp emphasize on why your product/service is better than your competitor's.
- Focus on the facts. Support your nomination with evidence of impact such as data, case study, statistics or feedback and testimonials.
- Highlight what has been done differently. The judges are keen to hear about innovation and new approaches.

By entering the Awards, companies/individuals authorize Messe Frankfurt Middle East/Intersec to use their entry descriptions, pictures
and company logos for the purpose of awards presentations and marketing. This is applicable to all shortlisted companies, individuals,
teams and winners.

Entry Process:

- Make sure you read the information in this pack before submitting your entry online at https://intersecawards2025.evalato.com/
- Check your eligibility and please read the criteria carefully, as the criteria for each of the categories are different
- Choose the right category. There are 16 categories to pick from, so play to your strengths and enter a category that reflects your entry
- Register yourself and create a unique login before you begin to enter a category
- Under Entry Name, write the name of your product/project
- You can start your application and save and return to complete at a later stage
- If you plan to submit entries in multiple categories, do not duplicate your submission, as it will not be allowed. **One product/service** can be submitted only as one entry. It cannot be replicated across categories. Please choose the most relevant one and make your submission. Refer to the product groups.

THE JUDGES

A judging panel consisting of senior professionals from the industry who bring a wealth of knowledge and experience to the evaluation process have been appointed to view and deliberate each and every entry.

Before the judging phase, every member of the judging panel declares if they have affiliations with any of the competing entries. In such cases, the judge does not get to rate any entries in the corresponding category.

JUDGING PROCESS

Round 1

- All the entries are reviewed and evaluated by the judging panel.
- The top-scoring entries from each category advance to Round 2 via the online voting process.

Round 2

- The judges will meet the representatives of the shortlisted entries in-person or online for a brief meeting to re-evaluate, following which
 a round of scoring takes place during this meeting.
- Should the judges also determine that it is necessary, you might be asked to submit samples and/or videos for the shortlisted entries, which they will assess during the Round 2 judging.

GENERAL TERMS & CONDITIONS

- Companies can submit entries in multiple categories, please select all the award categories that you wish to nominate in one go for an easier nomination process.
- Nominating the same product across categories is not allowed— Refer to the <u>product groups</u>, and submit your entry in the most relevant application.
- All nominations must be submitted online.
- Nominations must be in English and received by 20 AUGUST 2024.
- Nominations must be clearly written and remain within the submission guidelines.

- Messe Frankfurt Middle East / Intersec shall have the right to verify the information provided in each submission, if required.
- Messe Frankfurt Middle East / Intersec and the judges reserve the right to alter the categories or re-allocate entries between categories, as they see fit.
- In addition, if no entry is received in any category, or if the Judging Panel considers that no entry provides sufficient evidence of outstanding performance, no award will be given in that category.
- Nominations will be accepted in good faith and, notwithstanding any attempts to verify claims made in nominations, will be treated as true and accurate.
- Submission of entries indicates acceptance of the conditions of entry. In the event of any disputes or issues the decision made by the judges shall be deemed final. The organizers will not be obliged to justify their decisions or enter into any correspondence.
- All nominations and supporting information submitted will be treated as confidential and are only available for the Judging Panel whose members are bound by a Confidentiality Agreement.
